ndia is a land of many religions, cultures, languages, and festivals. It has a great heritage of spiritual scholarship: Home of four Vedas, Six schools of philosophy, and various other forms of scholastic literature. However, with the passage of time, some deviant social practices entered into its social setup and eventually got entangled with its legal order of social regulations and administration. There is a common perception that caste came into operation in Indian society between 2nd BC to 2nd AD. He wanted to see India free from caste and all sorts of communal contradictions. His vision of Prabuddh Bharat is based on the trinity of liberty, equality, fraternity where no one should be discriminated against on the basis of birth. For the realization of his vision, he helped prepare the Constitution of Independent India as a Chairman of the Drafting committee for the preparation of the Constitution. A few months before his Mahaparinirvan on December 6, 1956, Babasaheb Dr. B. R. Ambedkar took Diksha to embrace Buddhism again in order to get rid of the menace of the vicious social institution of caste and its resultant atrocious system of graded inequality. His vision of Prabuddh Bharat is based on all inclusive, socially cohesive and egalitarian social living. Let us take an oath on this great day to dedicate ourselves to the egalitarian mission of Babasaheb Dr. Ambedkar.

## BHARAT RATTAN DR. B.R. AMBEDKAR

#### A GLOWING TRIBUTE ON HIS 66th MAHA PARINIRWAN DIVAS

Today, the December 6th 2022 marks 66th MAHA PARINIVAN Divas of Bharat Rattan Dr. B.R Ambedkar, the founder of modern India through his contributions as the principal architect of Indian constitution and an undaunted social liberator. Glowing tributes are pouring in for this most luminous star in the galaxy of human intelligentsia. PARINIRVAN DIVAS: - Prinirvan Divas is a Sanskrit term that means liberation or freedom after death and is considered one of Buddhism's major doctrines and aspirations.

I bow my head in reverence to his unrelenting struggle for the emancipation of the voiceless people from the

shackles of social degradation going on against them for centuries at the hands of the so called upper sections of society. Born in a Mahar family of Maharashtra on April 14, 1891, Dr. Ambedkar grew up in the midst of harsh and severe social disabilities of the time which inspired him to raise his inner voice to stand against this unjust social order. With his profound arguments in the debates of the constituent Assembly he was able to secure

the justifiability of reservation for the down trodden communi-

AS A CONSTITUTIONALIST:- Babasaheb Dr. B.R. Ambedkar who had an extensive knowledge of more than fifty constitutions of the world proved himself as a nation builder who welded the entire nation after the end of British colonialism into one unified entity through his charismatic skills and wisdom in drafting the constitution of free India. Because of his penetrating intellect and profound scholarship and lucid exposition he was able to tackle the diverse intricacies inherently built in, in the social hierarchy of India ,for which he is admired all over the world.

FIGHT FOR THE RIGHTS OF THE WOMEN: - His painstaking and pioneering work as the first Law Minister of Free India resulted in the enactment of Hindu Code Bill for equality of women who had been deprived of their rights for centuries. Dr. Ambedkar had to face lot of opposition from Hindu Samaj against his daring courage to ameliorate the lot of the women.

DISTINGUISHED ECONOMIST: - With his exceptional expertise and versatile knowledge in the field of Economics Dr. Ambedkar was highly instrumental in his recommendations before the Hilton Young Commission in 1934 in the establishment of Reserve Bank of India. Dr. Amartya Sen, a Nobel Prize winner in Economics was highly inspired by the writings of Babasaheb and recognized him as the father of his Economics.

Dr. AMBEDKAR AS NOMINEE OF UN-TOUCHABLES IN LORD LOTHIAN COMMITTEE: -In 1932 the British Government appointed a committee with Lord Lothian as chairman to review some structural changes in Indian Government. Dr. Ambedkar was nominated as representative of untouchables and Babu Mangu Ram Mugowalia appeared as president, Shri Hazara Ram as General Secretary of Ad-Dharam Mandal and Shri Hans Raj in Punjab Assembly Hall, Lahore. This bears ample testimony to the fact that Babasaheb and Babu Mangu Ram Mugowalia were together on the same forum for safeguarding the interests of untouchables as a separate identity.





# "Struggle and more struggle, Sacrifice and more sacrifice"

The publishers of 'Jai Bheem' Madras proposed to bring out a Special Number of the magazine on Babasaheb's 55th Birthday in April 1947. They approached him to give a message to be published on the occasion. Babasaheb was not in favor of celebration of his birthday as here garded man-worship as perversion of democracy, and demoralizing to leader and his followers. He asserted that the sufferings and sufferings alone without counting the sacrifices or sufferings would bring the emancipation of his people. He emphasized that the Untouchables must develop a collective will to rise and resist and must believe in the sacredness of their task and develop a command determination to achieve their goal of fully recovering their manhood, come what may. He said greatness could be achieved only by struggle and sacrifice. Neither manhood nor Godhood could be obtained without going through the ordeal of fire. According to him most of the

down-trodden men fail to achieve greatin this ness race of life bethey cause have neither courage nor the determination to sacrifice the pleasures of the present for the needs of their future. His inspiring mes-

sage to the readers of 'Jai Bheem' is beacon for the people of marginalized sections.

Babasaheb said in his message of 13 April 1947: "You have asked me to send you a message on my 55th birthday for your Special Number. It is an unfortunate fact that in India the political leader is placed on the same footing as the Prophet. Outside India, people celebrate the birthday of their Prophets. It is only in India that the birthdays of both Prophets as well as the politicians are celebrated. It is a pity that it should be so. Personally, I do not like the celebration of my birthday. I am too much of a democrat to relish manworship which I regard as perversion of democracy. Admiration, love, regards and respect for a leader, if he deserves them, are permissible and should be enough for both, the leader and the followers. But worship of the leader is certainly not permissible. It is demoralizing to both. But I suppose this is all beside the point. Once a political leader is placed on the same footing as the Prophet, he must play the role of the Prophet and give a message to his followers in the same way as Prophet did. "I cannot give the Untouchables a message but I can tell them a tale from Greek Mythology and point out the moral. This tale is contained in a Homeric Hymn addressed to the Greek Goddess Demeter. This Hymn to Demeter relates how the great Goddess, in the course of her wanderings in search of her daughter, came to the court of Keleos. No one recognized the Goddess under the borrowed form of a humble wet-nurse; and Queen Metoneira entrusted to her care her latest born child the infant Demophoon, afterwards known as Tripltolemos. Every evening, behind closed doors, while the household was asleep, Demeter took little Demophoon out of his comfortable cradle and with apparent cruelty, though moved in reality by a great love and desires of bringing him eventually to the state of Godhood, laid the naked child on a glowing bed of embers. The child, Demophoon endures the fiery charcoal; he gathers strength from the ordeal. Something Superhuman is fostered in him, something robust, and something beyond all hope glorious. But Metoneira becoming anxious, says the legend, burst sud-




denly one evening into the room where the experiment was being carried on and guided by her mistaken fears, thrust aside the goddess at her work of foregoing the superman, pushed away the embers and took away the child with the result that she saved the child but lost the Superman and eventual God.

"This tale teaches that greatness can be achieved only by struggle and sacrifice. Neither manhood nor Godhood can be obtained without going through the ordeal of fire. Fire purifies, fire strengthens, so does struggle and suffering. No down-trodden man can achieve greatness unless he is prepared for struggle and suffering. He must be ready to sacrifice the comforts and even the necessities of the present for building up his future. To use the language of the Bible for the race of life all are called but only few are chosen. The reason is obvious. Most downtrodden men fail to achieve greatness in this race of life because they have neither the courage nor the determination to sacrifice the pleasures of the present for the needs of their future.

"Can there be a better and a greater message than what is contained in this legend? I can find one. It is the best and the most appropriate message I can think of for the Untouchables. I am aware of their struggle and their sufferings. I am

aware that in their struggle for liberty they have suffered more than I have. With all this, I can give them no other message. My message is 'struggle, and more struggle, sacrifice and more sacrifice'. It is struggle and struggle alone without counting the sacrifices or sufferings that will bring their emancipation. Nothing else will. The Untouchables must develop a collective will to rise and resist and must believe in the sacredness of their task and develop a command determination to achieve their goal. Their task is so great and the purpose so noble that as Untouchables should join in a prayer and say: "Blessed are they who are alive to the duty of raising those among whom they are born. Blessed are they who vow to give the flower of their days, their strength is of soul and body and their mite, to further the campaign of resistance to slavery. Blessed are they who resolvecome good, come evil, come sunshine, come tempest, come honor,

1956, Babasaheb said in voice choked with emotion: "...Whatever I have been able to achieve is being enjoyed by the educated few, with who, their deceitful performance, have proved to be the worthless lot, with no sympathies

for their downtrodden brethren... They live for themselves and their personal gains.. My lieutenants in whom I had full faith and confidence to run the movement are fighting among themselves for leadership and power... Tell my people, Nanak Chand, that whatever I have been able to achieve for them, I have done it single-handed,

passing through crushing miseries and endless troubles fighting with my opponents with also some of my own people who deceived me for their selfish ends...With great diffi-



come dishonor - not to stop until the Untouchables have fully recovered their manhood" (BAWS, Vol.17, Pt. 2, pp. 83-85).

The message of Babasaheb is as apt and relevant today for his people as it was then. Not only the legend has a message but the life itself of Babasaheb is living example of struggle and sacrifice for the cause of the unfortunate children of lesser God and the country. He sacrificed three sons, Ramesh, Gangadhar, Raj Rattan and a daughter Indu and suffered from multiple physical ailments for the cause of the people. But he stood like a rock that did not melt but turned the course of rivers. He served his people till his last breath. On the fateful day of 06 December 1956, he finalized typed draft letter to Buddha Shasana Concil and typed copy of Preface and Introduction to the book 'Buddha and his Dhamma' before breathing his last. His solemn vow "...to die in the service and cause of those down-trodden people among whom I was born, I was brought up and I am living. I would not budge an inch from my righteous cause "was, thus, redeemed. (Nanak Chand Rattu, Last few years of Dr. Ambedkar, pp. 112-116 and BAWS, Vol. 17, Pt. 3, P.

In last message to his people delivered through his Personal Secretary, Mr. N.C. Rattu on July 31,

If you continue to accept your lowly status ungrudgingly, continue to remain dirty, filthy, backward, ignorant, poor and disunited, they will allow you to live in peace. The moment you start to raise your level, the conflict starts. Untouchability is not transitory or temporary feature; it is eternal, it is lasting. Frankly it can be said that the struggle between the Hindus and the Untouchables is a never-ending conflict. It is eternal because the religion which assigns you the lowest status in society is itself divine and eternal according to the belief of the so-called high caste Hindus. No change warranted by change of time and circumstances is possible.





## An Assessment of Conference of Parties — 27

**V0I-14** 

he Conference of Parties-27 ended on November 20 in the Egyptian city of Sharm el-Sheikh. This conference was supposed to start from November 6 and last until November 18, but it ended on November 20 as no result was reached by November 18. In this conference, the item named Loss and Damages Fund has been passed, which is being considered as a major achievement of this conference. This item was an issue of discussion for a long time, but the developed countries were avoiding it with variousexcuses.

In the historical background, developed countries have mercilessly used large amounts of natural resources like air, water, and forests while developing their economies and have also polluted them badly. These countries have achieved huge milestones of industrial development by using coal, diesel, petrol, wood, and the like as energy sources and have emitted tons of greenhouse gases in the environment. As a result, the earth's average temperature has increased by 1.1 degree Celsius above the Pre-Industrial Revolution Period temperature. The rise in temperature has triggered rapid changes in climate, leading to a rapid increase in the frequency and severity of natural disasters such as droughts, floods, heat and cold waves. In this regard this is the year 2022, in which almost every country in the world has been affected by natural disasters. What is worth noting here is that the poor and developing countries are more affected by these natural disasters than the rich and developed ones. Therefore, poor and developing countries have been demanding for a long time from developed countries to compensate for the damage caused by natural disasters. Developed countries have been avoiding their responsibility so far. In this conference, while accepting this responsibility, they have agreed to compensate for the losses caused by natural disasters, which is considered a major and historic achievement of this conference.

One of the main reasons for holding the Conference of Parties-27 in Egypt in the African continent this year is that the 54 countries of Africa emit only 4 per cent of the total greenhouse gas emissions, while China alone emits 30 per cent of total emissions, the United States of America 15 per cent, European Union countries 9 per cent and India 7 per cent of greenhouse gas emissions. If we look at the historical background, the United States of America alone emitted 24.6 per cent of greenhouse gases into the atmosphere during 1750-2020. All African countries have emitted only 2.8 per cent of greenhouse gases in these years. Pakistan releases only 1 per cent of the greenhouse gases into the environment. This year (2022), one-third of Pakistan was affected by floods and 1700 people died. Somalia, Kenya, Ethiopia, and some other countries in Africa have been in the grip of drought during the last four years due

to which approximately 37 million people have faced starvation this year. Hundreds of people died and millions of people became homeless due to heavy floods in the countries of Nigeria and Uganda on the continent of Africa. According to the Notre Dame Global Adaptation Initiative Index, Africa emitted only 1.1 metric tons of carbon dioxide per capita in 2019. The United States of America alone emitted 16.1 metric tons of carbon dioxide per capita during this period, which is 11.4 metric tons more than the global average (4.7 metric tons) and while 54 African had emitted 3.6 metric tons less carbon dioxide per capita than the global average. Even with such low carbon dioxide emissions, these countries many times suffer from more natural disasters than developed countries. According to a survey concan get financial assistance on time. Many issues related to this fund are yet to be discussed. The biggest question is which country will pay how much and what criteria will be taken for it. The United States of America and European countries want China, which is currently emitting more greenhouse gases than any other country in the world, to contribute to the fund. The United Nations has currently placed China in the category of developing countries. All such issues will be discussed at the next year's Conference of Parties-28. So, this fund will remain in the files for one more year.

At the beginning of the Conference of Parties-27, it was said that this conference would focus on concrete implementation of the promises of rapid reduction of greenhouse gas emissions, but this conference, like

ducted in 55 poor countries, climate change has caused losses of 525 billion US dollars during the last two decades, but according to experts working in this field, the losses are much higher.

With the passing of the Losses and Damages Fund item, there is a ray of hope for the developing and poor countries that perhaps the developed countries will begin to compensate for the losses caused by natural disasters. One such promise was made by the developed countries at the Conference of Parties-15 in Copenhagen in 2009 to provide developing and poor countries with clean technologies to reduce greenhouse gas emissions of US\$100 billion annually by 2020 in the name of the Climate Finance Fund. Developed countries have been avoiding providing these funds. Every year they used to postpone giving the amount of fund by making some excuses. So far, developed countries have not provided the full amount as per this promise in any year. Only 78 billion US dollars in 2018 and 80 billion US dollars in 2019 were given in the name of the Climate Finance Fund.

In view of such behavior of developed countries, in order to make this promise of the COP-27 successful, similar items should be on the agenda and passed in the conferences being organized for climate change so that the needy countries

the previous conferences, has been very weak. There was no serious discussion of greenhouse gas emission reductions at this conference, while according to a United Nations report dated 26 October 2022, current greenhouse gas emission reduction pledges are limited to 1.5 degree Celsius by the end of this century. The pledge does not come down to doing. Temperature could increase by 2.5 degree Celsius by the end of the century and greenhouse gas emissions could increase by 10.6 per cent by 2030 compared to 2010 levels. According to a 2018 report by the Intergovernmental Panel on Climate Change (IPCC), greenhouse gas emissions would need to be cut to 45 per cent of 2010 levels by 2030 in order to limit global warming to 1.5 degree Celsius by the end of the century. According to a 2022 report by the Global Carbon Budget, if greenhouse gas emissions continue at current levels, there is a 50 per cent chance that the earth's average temperature would exceed the limit of 1.5 degree Celsius in the next nine years. According to this report, emissions of some greenhouse gases may increase by 1 per cent in 2022 over 2021. Greenhouse gas emissions could increase by 1.5 per cent in the United States of America and up to 6 per cent in India.

India proposed to reduce the use of all fossil fuels (coal, oil, wood,

diesel) but while this is not expected to reduce greenhouse gas e m i s s i o n s quickly, there may be benefits in the long term. European Union countries and the



United States of America supported the proposal, but oil-producing countries opposed it. This item was not included in the final conference draft in written form. In the Conference of Parties -26 India and China diluted the term phased out of coal into the phase down of coal into the final text.

All these reports came before the Conference of Parties-27 and United Nations Secretary General Antonio Guterres was of the opinion that the representatives of all the countries in this conference would be aware of the alarming warnings of these reports. Taking serious view of natural disasters like droughts, floods, heat and cold waves experienced in 2022 the world leaders of the different countries of the world would take concrete and serious decisions to reduce greenhouse gases emissions, but nothing happened. Guterres in his welcome speech to this conference has strongly said that now we do not have time to think and delay any more, we must all come together to make such an agreement that we will protect all countries of the world from the effects of climate change. Guterres also said that let's save or else be ready for a mass suicide. This serious issue was not openly discussed in the conference which is a matter of great concern. Smaller issues were discussed, such as that European countries proposed that all the countries in the world should submit a detailed report every year on the reductions in greenhouse gas emissions, which is now scheduled to be done every five years.

Currently, China, the United States of America, and India rank first, second, and third respectively in the use of coal for energy. China reiterated last year's pledge to begin reducing coal use after 2026. The United States of America has pledged to reach net-zero carbon emissions in the power sector by 2035 and in all other sectors by 2050. India has pledged to generate 500 Giga Watt of electricity from renewable energy sources by 2030. According to the Economic Survey 2021-22, coal consumption in India could increase by 1.3 to 1.5 billion tonnes by 2030, which would be 63 per cent more than the coal consumption of 2019-2020. These three countries China (30 per cent), the United States of America (15 per cent), and India (7 per cent) are releasing 52 per cent of the total greenhouse gases into the environment. Therefore, China and the United States of America should rapidly reduce greenhouse gas emissions and provide financial assistance to developing and poor countries that

suffer from natural disasters due to the increase in average global temperature every year through the Climate Finance Fund, and the Losses and Damages Fund. Although India emits a very small amount of greenhouse gases in the environment compared to these countries, it should contribute in this regard. With this, along with other countries, India will also be saved from natural disasters. European countries have also reduced greenhouse gas emissions this year by 0.8 per cent from 2021 level despite the ongoing Ukraine-Russia war and severe drought in 2022, which is

a positive trend. European countries have pledged to reduce greenhouse gas emissions by 55 per cent by 2030 from the 1990 level. These countries have already reduced their greenhouse gas emissions by 24 per cent from 1990 level during the period 1990 to 2019. In European countries, public transport is very smartly designed to reduce the use of private transport for reducing greenhouse gas emissions. The French government has banned short-flights (air travel) from April 2022 where there are train or bus service options of two and a half hours or less. This ban has been imposed to reduce the emission

of greenhouse gases in the country. In addition, almost all of the European countries have sidewalks and bike lanes on both sides of the roads for pedestrians and cyclists.

The United States of America has pledged to achieve zero greenhouse gas emissions from the energy sector by 2035, but most cities have only nominal public transportation facilities. Markets, food stores and places of work are so far from residential areas that even a common man cannot go without a private car/vehicle. According to the third installment of the Sixth IPCC Report, if greenhouse gas emissions are to be

rapidly reduced to save the earth, organisms, and people, modes of transportation, food, and living will have to be changed, otherwise every year millions of people and animals will fall victim to natural disasters. The governments of all the countries of the world should take the path of their economic development which passes through conservation of natural resources instead of depleting them. There is a dire need to make conscious decisions at conferences that are being held to save the earth and people from natural disasters for improving the environment. Time to act is now, tomorrow will be too late.



### Prime Minister Jawaharlal Nehru on demise of Babasaheb Dr. Ambedkar

"Mr. Chairman, I deeply regret to inform the House that a member of this House who had played a very leading part in many matters passed away a short while ago. I refer to Dr. Ambedkar. Dr. Ambedkar from many many years had been a controversial figure in Indian public affairs, but there can be no doubt about his outstanding quality, his scholarship, and the intensity with which he pursued his convictions, sometimes rather with greater intensity that perhaps required by the particular subject, which sometimes reacted in a contrary way. But he was the symbol of that intense feeling which we must always remember, the intense feelings of the

suppressed classes in India who have suffered for ages past under our social systems, and it is as well that we recognize this burden that all of us should carry and should always remember. It may be that some of us thought, as I have just said, that he



overdid the expression of that feeling, but I do not think that apart from the manner of utterance or language, anybody should challenge the rightness of the intensity of his feelings in that matter which should be felt by all of us and perhaps even more so by those who have not in themselves or in their groups or classes had to suffer from them. He was that. Therefore, he became this

But we in Parliament remember him for many other things and more particularly for the prominent part he played in the making of our

Constitution and perhaps this fact will be remembered even longer than his other activities. I am quite sure that every Member of this house will want us to send our deep condolences and message of sympathy to his family and to express our deep sorrow at his demise."

He is none other than 'Punjab da SherPuttar'Dharmendra. He is a born entertainer, acting is not a profession for him but it's his beloved. A director's actor, he could don a dhoti with the same ease with which he could sport a Roman Toga, he could be smoldering in a tuxedo and set a million hearts ablaze. The way his face emotes expressions is unparalleled and his sensitive eyes create an intriguing romance wooing his heroines. Simply dashing Dharmendrawith indelible romantic aura, remains true to his image of the lovable prince charming.

He blasted the silver screen and the movie halls were drowned in


He performed soft, emotional and romantic roles in the early days of his career and shunned away from being trapped in any particular image. With his sensitive face and eye-candy looks, he became the perfect choice for women-centric films. He portrayed a sensitive jail doctor in "Bandini" (1963) while "Anupama" (1966) gave him the patina of an actor. He willingly experimented to do the villain's role in "Aayee Milan Ki Bela" (1964)

"Johnny Gaddar"(2007). "Yamla PaglaDeewana" (2011) etched Dharmendra as a comic actor far beyond his years.

During his early career, he was eager to act in Punjabi



1964, he got the plum role of Geeta Bali's brother-in-law in Rajinder Singh Bedi's "Rano". However, the film got scrapped due to the tragic death of Geeta Bali. Shocked Dharmendra decided to shun Punjabi films except doing guest or special appearances in friendly Punjabi ventures post 1970.







a thousand whistles merely on his entry. He took rapid strides to become the poster boy for the tendon. He is known as the most handsome actor to have ever walked the soil of Indian showbiz. A top draw at the box office, his towering talent got overlooked because the industry didn't know how to deal with his Greek god looks. He connects with the world through social media and is a regular twitter, sharing glimpses from his old movies.

During his initial career years, hecountered the mercurial rise of Shammi Kapoor and then contended with Rajendra(Jubilee) Kumar. In 1970s, he lived and thrived under the shadow of the Rajesh Khanna phenomenon. The marquee crown continue to elude him with the entry of angry young man Amitabh Bachchan. But Dharmendra was the rock that wouldn't budge and he remained industry's most favourite leading man. He earned the epithet of 'bankable star' because his films earned the proverbial big bucks.

Dharminder Singh Deol (Dharmendra) was born to a school teacher KewalKrishanSingh Deoland Satwant Kaur in Nasrali village, (District Ludhiana, Punjab) on December 8, 1935. He received his early education from Government School, Lalton Kalan (Ludhiana) and did his intermediate from Ramgarhia College, Phagwara. He was fascinated by the films right from his childhood. As class IX student, he saw his first film "Shaheed" (1948) and he was spell-bound. As an adolescent, he got addicted to films,

not a football player. He and his contemporaries Manoj Kumar and Shashi Kapoor used to sit on a bench in the studios and wait endlessly for a much needed break. Frustrated, Dharmendra decided to return to Ludhiana, but then the lady luck smiled on him. With the persistent efforts of Filmfare editor L.P. Rao, he got a second lead role in Arjun Hingorani's film 'DilBhiTera Hum BhiTere' (1960) and was paid a signing amount of Rupees Fifty

During the preview show of the film, the financiers disapproved Dharmendra and advised the producer to replace him with an established actor. However, director Arjun Hingorani stuck to his guns. Dharmendra started as a nervous and overtly concerned actor playing the role of an unemployed youth Ashok, who advertised for Cavander cigarettes on busy streets by wearing high stilts and spent his nights on the footpath. Ironically, no body recognized Dharmendra at the premiere of his first movie and he returned home by a local train. This film tanked at the box-office and he was again on the roads.

Once again, Mr. Rao came to his rescue and got him role in Bimal Roy's "Bandini" (1963). Simultaneously, his first signed film "Shola Aur-Shabnam" (1961) also got started. This time he was lucky and both the films proved box-office success. His performance was greatly appreciated in Anpadh (1962) and many offers came in his pocket. Renowned directors like ChetanAnand, PhaniMajumoutshining the hero Rajendra Kumar. The bare-chested Dharmendra looming over MeenaKumari in PhoolAur-Patthar(1966) became the most striking image of the film that catapulted him to stardom.

He did James bond type action spy roles in "Ankhen" (1968), "Jugnu" (1973), "Loafer" (1973) and "Shalimar" (1978). In "Khamoshi" (1969), he has briefly shown his gorgeous rear profile and left the audience wanting more. He played overly sensitive writer in "NayaZamana" (1971) and "Phagun" (1973) anda shy romantic poet in "Black Mail" (1973). In his new incarnation, he played the flirtatious Veeru in "Sholay"(1975) and Professor ParimalTripathi in "ChupkeChupke" (1975) where his comic timing practically anchored the entire film.He donned a black frock and indulged in lance fights in swashbuckler "Dharam Veer" (1977).

His later films like "Ghulami" (1985), "Hathyar"(1989) and "Batwara"(1989) showcased a mature Dharmendra. However, the masalaaction super hit film "Hukumat" (1987) transformed him into a veritable 'Action Icon'. During the 1990s, Dharmendra did a lot of average films simply because he wanted to be in the midst of what he loved the most. After a four-year hiatus from acting, he staged a comeback with character roles in "Apne" (2007) and "Life in a... Metro" (2007), both the films were critically and commercially successful. Dharmendra is a hungry actor and he gave superb improvised

His first Punjabi film was Kankan De Ohle (1971) in a special role with Asha Parikh. In DukhBhanjanTeraNaam (1972), he played a brief role of a cartman. In Do Sher (1974) he was a police officer who disguised as Malang to nab the criminals. Next year, his special appearance as BholuRickshawala in Teri MerilkJindari (1975) was to launch his cousin Veerendra. He continued to do small roles off and on as guest appearances in films like "Main Papi Tum Bakhshanhaar", "Giddha", "Nachdi-Jawani", "Ambri", "Putt Jattan De", "Santo Banto", "RanjhanMeraYaar", "QurbaniJatt Di", "Double DI Trouble" (Double role), "Jora 10 Numbaria" and "Jora- the Second Chapter" etc. The leading ladies in B-town were swooning over Dharmendra, the India's answer to James Dean. He was chivalrous and his soft etiquette with the ladies was well known. He acted opposite a bevy of beauties of the day Nutan, MeenaKumari, Saira-Banu, Mala Sinha, Tanuja, Nanda, Sharmila Tagore, Mumtaz, Parveen Bobby and ZeenatAman etc. But his most popular pairing was with the dream girl HemaMaliniin more than 20 films. They fell in love on the sets of "Tum Haseen Main Jawan" (1970) and finally got married on August 21, 1979. They have two daughters Esha and Ahana out of this wedlock. He appeared with his daughter Esha in HemaMalini's venture 'Tell me O Khuda' (2012).







#### **Hazel Avenue Improvement Project Completed**

In 2008, the Sacramento County Department of Transportation (SacDOT) began work on transforming Hazel Avenue. That's when the first phase kicked off at the Highway 50 interchange. The entire project would stretch from Highway 50 up to Madison Avenue. It was broken up into three separate phases, with Phase 1 running from the highway to Curragh Downs Drive. Constructing this project resulted in big changes to the look and feel of Hazel Avenue. The biggest change was widening the

road from four to six lanes. Other upgrades include constructing new bicycle and pedestrian facilities, traffic signal modifications, and replacing the center turn lane with a

raised/landscaped center median.

One of the biggest challenges in Phase 1 was adding extra lanes on the bridge over the American River. Before that could occur, engineers needed to complete the design, secure environmental permits, and ac-

quire the land rights Phase 2 and Phase 3 dents.

A year after the design was com-

pleted and three years after the Board of Supervisors gave its 2006 greenlight for the project, construction crews started work. The first phase officially finished in 2011, with a ribbon cutting at the Nimbus Fish Hatchery.

in 2010 with the important pre-construction work of design, environmental studies, and the acquisition of

properties before construction began. The heavy lifting started in 2016, as construction began from Curragh Downs Drive to Sunset Avenue. This phase of the project included a partnership with the Sacramento Municipal Utility District (SMUD) and the telecom utilities to underground the overhead utility lines. SacDOT also partnered with the Fair Oaks Water District to replace their aging water distribution system within the project limits. Construction on Phase 2 was completed in 2018.

With two phases down, SacDOT turned its sights onto the homestretch of Phase 3. SacDOT began that construction from Sunset Avenue to Madison Avenue in November 2020. As Phase 3 started, residents and commuters began to see how this facelift was helping to rejuvenate Hazel Avenue. After the end of Phase 3, the 2008 vision for new sidewalks and bike lanes came to fruition. These new amenities provided alternative modes of trans-



necessary for the project. The alignment for of the project required the purchase and removal of over 40 houses, as well as relocation assistance for the impacted resi-

The second phase kicked off

portation for those wanting to get out of their cars. The construction also brought new bus stops that allow traffic to flow while buses pull into a turn-out giving passengers a safer way to board and exit.

Along with the road construction, the skyline along Hazel Avenue was decluttered. This occurred because SacDOT collaborated with SMUD and the telecom utility companies to remove overhead wires that crisscrossed the area. SMUD and the other utility companies removed nearly 100 utility poles and placed their lines underground. With the undergrounding of utilities and the installation of continuous sidewalks and bike lanes, the public can safely stroll or ride bikes from Madison to the Nimbus Fish Hatchery, and see birds instead of a power line overhead as they enjoy the outdoors.

It's been 16 years since the Board of Supervisors approved the \$70 million project, and as construction crews put the finishing touches to Hazel Avenue, SacDOT would like to thank everyone for their patience throughout the three phases of

local level, there were some issues that were voted on that will have major importance to us on the local level that I have seen very little coverage on - even by local papers. For my monthly article. I want to highlight the three most impactful ones so that you can know what to expect. And even though the votes are still being counted, each of these three I am going to describe below have enough votes counted for us to know with high confidence how they are going to wind up.

First is Measure A, which was a local vote for all residents of Sacramento County that would have raised the sales take by a ½ cent per \$1.00 spent, raising around \$212,500,000 annually until 2063 to spend on various transportation purposes like roads, public transit, vehicle emission reduction. Normally when local taxes are voted on, if the measure discloses exactly where the money will be spent (which was the case here) it needs to get 66% or more votes in favor in order to pass. But a quirk in the law allowed this one to only need to get above 50% in order to pass, which made it seem like a foregone conclusion that it would easily get enough votes in order to pass. But in a huge surprise, even though the "yes" campaign spent well over \$2,000,000 the measure failed which will likely put a stop in the near future to more local transportation taxes showing up on the ballot.

Second is Measure B, which was a local vote in Sacramento County to allow the County to tax cannabis. This failed to reach the 66% needed, which means we will not be having cannabis stores popping up in the unincorporated parts of the County. This will likely not be the end of the efforts to pass this, and I would expect future tax proposals like


In 2019, SMF similarly won the top midsized airport award - the award was not issued in 2020 or 2021 due to the pandemic.




