May Day Celebrations & Babasaheb Dr Ambedkar's Contributions for Laborers in India



May Day Celebrations & Babasaheb Dr Ambedkar's Contributions for Laborers in India Prem K. Chumber Editor-in-Chief: www.ambedkartimes.com Ambedkar Times & Desh Doaba Weekly Newspapers Bharat Ratan Bodhisattva Babasaheb Dr Bhimrao Ramji's contribution towards the emancipation and empowerment of the working class in India both during the freedom struggle as well as after India's independence is worth remembering on the historic May Day: celebrated worldwide as International Workers' Day, also known as Workers' Day and Labour Day. It was chosen to be International Workers' Day at the International's second congress in 1891 to commemorate the 1886 Haymarket affair in Chicago wherein on 1 May workers of various industrial units observed general strike for the eight-hour workday. On 4 May when the Chicago police tried to disperse a public assembly in support of the general strike an unidentified person threw a bomb, which led to police firing resulting in the death of seven police officers, at least four civilians and wounding of sixty police officers and unknown number of civilians. This was led to the arrest of hundreds of labour leaders and their sympathizers. Later on, four of the arrested ones were executed by hanging. It was coincidence that Babasaheb Dr Ambedkar was born in 1891 and came to acquire higher education in the United States of America in 1913. What he learnt during his three years (1913-16) stint at Columbia University in New York City in the class room sessions of his great professors - John Dewey, James Shotwell, Edwin Seligman and James Harvey Robinson made him struggle for the emancipation and empowerment of the laborers on his return in his own country during the British as well as after India's independence. During his tenure as a Labour Minister and as the Labour Member of the Viceroy's Executive Council between 1942 and 1946, he worked hard for the reduction of working hours from 12 to 8 Hours a day. His contributions towards granting the rights of the laborers are manifold: establishment of Employment Exchange, Employees State Insurance (ESI), Indian Statistical Law, Compulsory Recognition for Trade of Union, Indian Factory act, Dearness Allowance (DA), Paid Holidays, Health Insurance, Extra pay for Overtime, Legal Strike Act, Provident Fund (PF), Labour Welfare Fund, Technical Training Scheme, Mines Maternity Benefit Act, Women Labour Welfare Fund, Women and Child-Labour Protection Act, Maternity Benefit for Women Labour, Equal Pay for Equal Work irrespective of the Sex, Restoration of Ban on Employment of Women on Underground Work in Coal Mines.

As far as the public domain of working class activism is concerned, Dr Ambedkar was always acted as front soldier for the rights of workers. His contribution in highlighting the plight of Dalit workers access in the highest paid textile mill weaving departments is well known. Dalits were not allowed to work in these textile mills for the fear of pollution caused by their saliva to wet the thread during the weaving process to tie the knot, each time the weft bobbin required a replacement. Dr Ambedkar brought this issue in the public during the famous 1928 Bombay Textile Strike. He threatened to dissuade Dalit workers from joining the strike if his demand for Dalits' access to all kind of jobs in the mills was accepted. His contributions towards the bill to abolish the Mahar Watan and Khoti abolition bill were among the several prominent labour welfare measures undertook by him. Abolition of Punjab Land Alienation Act of 1900 was yet another legal relief to the non-agriculture classes, including Dalits, to overcome their exclusion from the land ownership rights. UNO observes it as an important day under the patronage of UNESCO. In India it is celebrated at federal level as a "ANTARRASHTRIYA SHRAMIK DIWAS" and the other states observe it with different names in honor of the hardworking people who work for the betterment of our society.

HISTORICAL PERSPECTIVE IN INDIA:

- With the dawn of Industrial Revolution the poor working conditions with hazardous environments for workers in the factories and other establishments needed improvements. It resulted in the establishment of many labor Unions and other channels for comforts of the working people.

ROLE OF Dr. B.R. AMBEDKAR: - Dr. B.R. Ambedkar fought his way against poverty, adversity, injustice to pinnacle of leadership. As a member of the Executive Council of Viceroy from 1942 to 1946 and as Law Minister of India, Dr. Ambedkar, based on his extensive study of the labor problems and the labour legislations in Europe, was responsible for introduction of many landmark decisions for improving the working conditions of the labour. Some of them are as under:-

- 1. Reduction in Working Hours (From 14 Hours to 8 Hours)
- 2. Creation of Tripartite Organization for settlement of Industrial disputes.
- 3. Ban on employment of women on underground work in coal mines and Maternity Benefit Act.
 4. Provision for Dear-
- ness Allowance

5. Employees state Insurance Corporation6. Pay commissions.

CONTRIBUTIONS OF BABU JAGJIVAN RAM:

- As labor Minister in Jawahar Lal Nehru's cabinet, Babu Jagjivan Ram was the first labour Minister to preside over International Labour Organization in Geneva. He got enacted many Bills into laws for the benefit of the labour classes. Alongwith Dr. Ambedkar he was able to steer through many other labor Acts.
- 1. Industrial disputes Act, 1948
- 2. Minimum Wage Act, 1948



The book in hand – Rashtar, Rashtarbad aur Ambedkarbad written in Hindi is a compilation of 21 essays on interesting subjects pertaining to some of the issues of current and contemporary interest and relevance. The book has been dedicated to the Dawarka ji's father Bhagwan Dass Raju who himself was an Ambedkarite activist of his times. Dawarka Bharti acknowledges this fact with a sense of pride and gratitude that his pursuits to know and adopt Ambedkar Thoughts were initiated and instilled in him by his father.

The book was formally released on April 14, birth anniversary of Babasaheb Ambedkar at Sidharath tion in these days of growing intolerance in the system and the society. Bharti Sahib in his home-grown humbleness says at the outset, "मेरे लिखने से यां न लिखने से बहुत फर्क पड़ जायगा; ऐसा नहीं हैं; पर लगा शायद चुप रहना सहमतीन मान ती जाये मेरी ". It may be taken at its face value. Some of the essays have been devoted to various aspects of Thought. Ambedkar One of the headings rightly conveys the mind of the author -आंबेडकर एक आइकॉन ही नहीं; बैचारिक जवालामुखी भी है. Yet another aspect of Ambedkar Thought reflects in the essays on Buddhism and Buddhist philosophy and also on conversion, especially



in any "BAAD" but still I think, as a lay man, Ambedkar Thought, in concrete and crystallized form, stands for the betterment of the community, society and the humanity at large by way of harmonious social set-up, democratic polity, and equitable economic order, humanistic and compassionate spiritual endeavor which may be termed as Ambedkarbad. As regards the ongoing unfortunate strife ridden atmosphere in the country as raised in some of the essays in the book, I said that we all should revisit and read Babasaheb's speech of November 25, 1949 delivered in the Constituent Assembly before the constitution was finally passed and adopted. As a visionary leader he raised questions and answered himself which are as relevant today as it was in 1949.

I hope that the book will be received well. Dawarks Bharti is fighting fit to give us more at his age of past seventy. I wish him good health and prosperity in the years to come.

New Senate Bill Denying Law Enforcement Funding (SB 1464)

With the legislature back in session, legislation has recently been introduced that compounds the progressive pillars of excessive mandates and



defunding police. Below, I would like to explain what this bill is, and why I believe it is a horrible idea.

Over the past couple years, we saw an onslaught of public health orders introduced at the state and local levels in response to the COVID-19 pandemic. These health orders came with requirements for masks in public places, the closing of businesses, and other aspects of "social distancing." Following the health orders, many law enforcement agencies announced that they would not be dedicating resources to the enforcement of health. In response, we now have Senate Bill (SB) 1464 which would deny funding to any law enforcement agency that adopts a policy to not enforce health orders in the future, and transfer that funding to public health agencies that are unelected and do not answer directly to the people.

During my campaign for County Supervisor, I made a promise that when I vote I will always ask the questions: Is it constitutional? Can we afford it? And does it make sense for our community? For this bill, the answer is no on all three counts.

It is not Constitutional. The mandate would impede the Constitutional discretionary authority of elected Sheriffs, and the Constitutional discretionary authority of elected County Supervisors who are best able to act in the interest of their community.

We cannot afford it. During the COVID lockdown, Sacramento County saw a reduction in staff at the Sheriff's department. We lost officers who retired or resigned, and the circumstances of the COVID pandemic regulations disrupted our normal annual training and recruitment, leaving us short by 138 Deputies. COVID mandates exacerbated the homeless problems as we were instructed not to move homeless camps. We saw in-

creases in response times and the shifting of officers off certain assignments to partake in patrols. Ultimately, the citizens of Sacramento County shouldered the burden.

It does not make sense for our community. We need more law

enforcement funding, not less. Along with the COVID challenges, more than 20,000 inmates were released from jails statewide in 2020, we are coincidentally seeing an increase in violent crimes. So, with crime up and law enforcement staffing down, why would anyone see it as appropriate to further reduce law

enforcement budgets?

During my years as a Supervisor, I have watched as the legislature has systematically eliminated tools and disabled law enforcement when it comes to enforcing the law. Felony crimes in California have been reduced to a misdemeanor. Anyone can walk into their local store and steal up to \$950 worth of merchandise without serious consequences. For large corporations, this is just considered "a cost of doing business" but for small businesses this is one more nail in the coffin of their dying business. Homeless individuals can defecate on sidewalks and drug users can scatter their needles throughout our parks. The unintended consequences of policy over time have stripped our law enforcement of tools that used to keep neighborhoods and businesses safe.

It is hard to imagine a world where we enter another pandemic (assuming this one ever officially ends) and it is silly to assume that law enforcement has the time to send a deputy to issue a citation to every person who enters a public space without a mask.

SB 1464 seems to imply that those who were not ready to comply were worse offenders than the 20,000 people released from jails. No one who wishes to not wear a mask or follow social distancing protocol has any right to harass or assault a public health worker or a customer service employee who asks them to follow such protocols and anyone who becomes less than peaceful under such circumstances is likely deserving of the attention of law enforcement. At the same time, if a person peacefully or respectfully declines as a form of protest or exercise of medical freedom, it is their right and Law Enforcement is bound by their oath to uphold those rights.

Defunding law enforcement

agencies for how they prioritize their response to crime in the community is entirely backwards. Perhaps a carrot in the form of additional resources to enforce laws already on the books rather than the stick of defunding already overburdened agencies is a better approach to enhancing public safety. I hope our legislators see the flawed logic and withdraw SB1464.

County DHA Launches Food Insecurity Pilot Program

With applications for CalFresh and the California Food Assistance Program rising as the effects of the pandemic grow year over year for those with low or fixed incomes, the Sacramento County Board of Supervisors heard the pleas of the community – we need to address food insecurity in our County. In response, the Sacramento County Department of Human Assistance (DHA) has launched a Food Insecurity Pilot Program – aimed at lessening the impact the pandemic has had on individuals struggling to feed themselves and their families.


The pilot program includes increased funding to the food bank, providing food delivery services and working with local non-profit partners to ensure the services are reaching



those that need them most. The BOS approved \$3,859,993 in American Rescue Plan Act (ARPA) Revenue Replacement Funds and \$250,000 in APRA funding to implement a County Food Insecurity Pilot Program.

The County received proposals directly from the community to address food insecurity that mirrored the restaurant meals program administered during the pandemic, which saw an increase in needed food supports.

DHA is contracting with Family Meals Sacramento (FMS) and the National Association for the Advancement of Colored People (NAACP) for an initial pilot program of one-year to ensure individuals and families are receiving the food services. DHA chose FMS and NAACP for their experience and their ability to expedite restaurant meal services to families experiencing the greatest need. Funding allocations:

FMS (Restaurant Meal Service): \$1.25 million

NAACP (Restaurant Meal Service): \$2.5 Million

NAACP (Outreach on Food Insecurity): \$250,000

County Administrative Costs: \$109,993

Total Program Allocation: \$4,109,993

While ARPA funds can be used to fund this program directly, DHA determined there would be significant challenges in allocating ARPA funds to restaurant meal services if the partners were unable to meet the ARPA compliance and reporting guidelines – which are fairly strict. It was also determined the program would become an administrative burden and create an audit risk if partners were unable to comply with program rules, thus creating further hardship on restaurants, the community and the County.

Administering the ARPA Food Insecurity Pilot would also require extensive training for all partners and restaurants, increasing the costs of County administrative support significantly. Thus, DHA determined that using General Fund in lieu of ARPA funding for this program would allow

for a more effective and streamlined approach to the implementation of the program. However, in order to still fully utilize the ARPA funds available, but allow for more flexibility and versatility in the program, DHA requested the funds come in the form of revenue replacement to cover the full program costs.

In addition to the information provided above, in the coming months, DHA will be seeking approval from the BOS for two additional contracts the food bank and meal delivery services. The funding for these two contracts has already been approved by the Board, adding an additional \$2 million to address food insecurity in the County.

Fire Prevention Efforts Underway in Regional Parks

Fire season seems to start earlier and earlier, and the Sacramento County Department of Regional Parks has already initiated its multi-pronged plan to reduce fire risk, defend wildlife habitats and protect our natural resources and the neigh

(Continue from page 3) borhoods adjacent to the parks.

For its 2022 Fire Fuel Reduction Action Plan, the Department of Regional Parks has lined up sheep and goat grazing contracts, is utilizing maintenance crews to maintain fire breaks, and is issuing fuel break maintenance permits to properties bordering Park properties.

To decrease the number and size potential of wildfires in our parks system, the techniques used will be applicable for each area and will include:

Firebreaks – A combination of mowing, soil discing and targeted herbicides will be used where appropriate to create perimeters around open fields, along fence lines and be-



hind neighborhoods. This work is scheduled to be completed by end of June.

Ladder Fuel Hand-Crews – In limited, hard-to-reach areas, hand-crews will remove vegetation that allows the potential for a fire to climb up or move into urban areas.

Grazing – There are hundreds of acres of undeveloped or protected land in our Regional Parks. Goats and sheep are ideal for vegetation management and are great at eating down weeds, bushes and grass that manned crews cannot get to. Grazing is expected to occur between April and the end of June.

Annual Encroachment Permits

- Residents who live adjacent to
Regional Parks' properties are able to

apply for free annual encroachment permits to maintain a fire break behind their property line. These allow residents to string-trim grass and weeds for up to 50 feet beyond their private property line. To request a permit, provide your name, address and contact information to Regional Parks at parksinfo@SacCounty.gov.

Additionally, the Ranger Division will continue its increased education and enforcement efforts related to illegal fires and cooking along the parkway in an effort to reduce the number of new fire outbreaks.

Visitors to Sacramento County Regional Parks should be aware of the following regulations:

Open flame fires are not allowed and barbequing is only permitted in designated picnic areas.

Smoking is only allowed in developed picnic areas, asphalt surfaces, golf courses and levee tops along the American River Parkway.
